1.以各种已知或将来出现的形态、格式和媒介(包括但不限于纸质、数字化和电子形式) 出版、复制、发行、展览、传输、汇编、存储该论文;

2.翻译、改编该论文、利用该论文制作摘要或从中提取部分片段,以及利用该论文制作 其他形式的衍生作品,产生的摘要、外文版等衍生作品同样适用上述第1款;

3.将上述权利的全部或部分转让或许可给第三方。

3. Transfer or license all or part of the above rights to a third party.

The content of the journal is open access under the Creative Commons License. Permitted

third party reuse of the articles published by the journal is defined by the following user license:

The term of copyright transfer is the legal protection period prescribed by law, and the regional scope is all over the world.
